## CLASS RULES AND REGULATIONS

1. **Payments:** Tuition is calculated on 12 equal monthly payments. Students will receive 3-5 lessons during the month. Tuition is due by the 1st lesson of the month. Your payment reserves your child's spot for the month. Students who take a class during a month are required to pay the full months tuition. NO PRORATING FOR MISSED CLASSES. NO REFUNDS or credits of tuition fees paid. PLEASE REGISTER CAREFULLY. Class space not guaranteed until full payment is received.

2. Late Fee: A \$15.00 late charge will be added to your account if payment is not received by the second lesson of the month.

3. Cancellation: Your child will be automatically enrolled from month to month. A 2 week written notice, before a new month begins is required to withdraw from a class. Charges accrue if notice is not given.

4. If at any time you take a break you are required to call before showing back up to your class in order for us to ensure there is still a spot for your child.

5. <u>Make Ups:</u> With advance notice (except illness) that your child will be absent, one make up is allowed per month. Must be pre-signed up and done within the month of the missed class or forfeited. Student must be currently enrolled to do a "make up". Missed make up may not be rescheduled.

6. Credit is not given for missed classes. Absences may be issued through the office.

7. MVG reserves the right to remove a child from a class for non-payment and/or improper behavior.

8. There will be a **\$30.00 service charge** for all checks returned for insufficient funds.

9 **Observation:** Parents are welcome to observe classes, but must remain in the viewing area upstairs. We ask that parent's do not "coach" their children from the viewing area. Children not in a class must be supervised at all times. Students only are allowed in the training area.

10. Client Information: Please notify the front desk with any changes to your name, address, phone numbers and emergency contacts.

11.<u>Attire:</u> Students must wear clothes that are non-restrictive and free of buttons and zippers. Long hair must be pulled back off the face. Bare feet are preferred for easy traction. MV Gymnastics has a good selection of gymnastics clothing for sale in our Pro Shop.
